She is a Past-President of the Georgia Federation of Republican Women and finds the principles she learned at home and from her time with Reagan to be most helpful in trying to build a national and statewide network that sees and acts upon the urgent issues facing our State and Country. She is often called upon to write editorials on Conservative Women in politics.

Her unwavering support for our military continues as she serves on the Birdwell Foundation for military and first responders who are in crisis. The Foundation aims to support all who suffer from combat related PTSD and MST.
